Welcome to LoveStory.sg! LoveStory.sg is a dating and matchmaking service for singles that combines social networking with dating and events. All services provided by LoveStory.sg are for single adults 20 years old and above.

LoveStory.sg is owned and operated by PerfectMatch Pte Ltd, a Singapore registered company. You can contact us on any of the following methods:

This legal notice applies to the entire contents of this website, LoveStory.sg, hereinafter referred to as “Website”, and to any form of correspondence made between us and you.

Please read the following Terms and Conditions carefully before using this Website. Registering as a user for this Website indicates that you acknowledge to have read and understood and to accept the Terms and Conditions stated below. You shall accept the Terms and Conditions by making the necessary declaration on the Website. **Please do not use this Website if you do not accept any of the Terms and Conditions.**

Once you have successfully completed your online registration process, your free membership will be activated and you will have entered into a legally binding contract for the provision of the facilities made available for members via the Website, hereinafter referred to as “Service”, for the entire duration of your membership.

1. MEMBERSHIP

1.1 Eligibility

You must be 20 years old or above and single to register as a member of this Website. By registering as a member, you represent and warrant that you have the right, authority and capacity to enter into this Agreement and to comply with all the Terms and Conditions contained in this Agreement.

1.2 MEMBERSHIP

After registering online, you will be a member of the Website free of charge. Free membership will only entitle you to participate in the free-members services being offered. In order to access premium features and services such as the ability to communicate with other members, you must become a paying subscriber or “Premium Member” to the Website. Accordingly, your use of those additional premium features and services is conditional upon the payment of the relevant subscription fees.

1.3 SUBSCRIPTION FEES

The relevant subscription fees can be viewed on the subscription page. The subscription fees are part of this Agreement. These subscription fees are subject to change at any time, but we will give you reasonable notice of this before any changes are implemented. Should you not wish to accept any changes made to the subscription fee, you may terminate your membership by writing to our address provided above, by cancelling the subscription using Paypal or by using our “Contact Us” form. Please note that we will send you an e-mail for your confirmation should you cancel your subscription using Paypal.

1.4 PAYMENT

Subscriptions can be acquired at the prices, for the periods and by various payment methods such as credit card, cheque and bank transfer. For credit card subscription, please refer to the instructions found on the subscription page. Such mode of payment will be billed monthly. For subscription by cheque and bank transfer, please refer to the relevant document found on the subscription page. Prices are stated in Singapore Dollars (SGD) and include all applicable taxes unless otherwise stated.

With the exception of credit card subscription, which will be billed monthly, we do not auto-renew your membership unless you specifically select this option. If you have selected to be auto-rebilled, then, the subscription will be auto-renewed for the periods stated. You can cancel the auto-renewal by writing to our address provided above or by using our “Contact Us” form.

We may at any time change our price for a subscription. The new rate takes effect if you apply for a new subscription, whether or not it is your first subscription, after we have provided reasonable notice before implementing any changes. The new rate will also affect auto-renewals of existing subscription, with reasonable notice provided and an option for termination of membership should you not wish to accept such changes.

1.5 RECURRING BILLING

The subscription plans to the Service usually consist of an initial period, for which there is a one-time charge, followed by recurring period charges as agreed by you. By entering into this Agreement, you

acknowledge that your subscription has an initial and recurring payment feature and you accept responsibility for all recurring charges prior to termination of your membership and therefore authorise LoveStory.sg to levy such charges.

LoveStory.sg may submit periodic charges (e.g. monthly) without further authorisation from you, until you provide prior notice, which it to be confirmed in writing upon request by LoveStory.sg, that you have terminated this authorisation or wish to change your payment method. Such notice will not affect charges submitted before LoveStory.sg reasonably could act to terminate your authorisation or change your payment method. Please note that LoveStory.sg do not store any credit card details.

1.6 INFORMATION REQUIRED FOR BILLING

You must provide current, complete and accurate information for your billing account. You must promptly and regularly update all information to keep your billing account current, complete and accurate, such as a change in billing address, credit card number or credit card expiration date.

You must promptly notify LoveStory.sg if your payment method is cancelled, e.g. for loss or theft, or if you become aware of a potential breach of security, such as the unauthorised disclosure or use of your username or password. Changes to such information can be made on the Paypal website. If you fail to provide LoveStory.sg any of the foregoing information, you agree that LoveStory.sg may continue charging through Paypal for any use of the service under your billing account unless you have terminated your subscription for the service, which is to be confirmed in writing upon request by LoveStory.sg.

1.7 MEMBER ID, PASSWORD AND ACCOUNT SECURITY

As part of the member registration process, you will be required to select a member ID (username) and password. We may refuse to accept any username for any reason, including that the proposed member ID impersonates someone else, is or may be illegal, is or may be protected by trade mark or other intellectual property law, is vulgar or otherwise offensive, or may cause confusion, as we determine in our absolute discretion.

You are solely responsible for maintaining the confidentiality of your username and password that you designate during the registration process on the Website with the Service and agree not to transfer or resell your use of or access to the Website to any third party. You are also fully responsible for all activities that occur under your username and password.

You agree to immediately notify LoveStory.sg of any unauthorised use of your username and password or other breach of security, and also to ensure that you exit from your account at the end of each session. LoveStory.sg will not be liable for any loss or damage arising from your failure to comply with this provision.

You should exercise particular caution when accessing your account from a public or shared computer so that others are not able to view, record your password or other personal information. If you share your computer with others, you may wish to consider disabling your auto-sign in feature if you have linked your Microsoft.Net Passport or AOL ScreenName to your LoveStory.sg account.

1.8 CONTENT OF PROFILE

You are solely responsible for the content of your profile, messages, video and audio recordings and other materials you may upload to the Website and its Service or transmit to other members of the Website and its Service.

1.9 TERMINATION OF MEMBERSHIP

This Agreement will remain in full force and effect while you are a member of the Website and its Service. You may terminate your membership at any time, for any reason, by writing to our address provided above, by cancelling the subscription using Paypal or by using our "Contact Us" form. Please note that we will send you an e-mail for your confirmation should you cancel your subscription using Paypal. The request for termination will be effective upon receipt by us of your written or e-mail notice or confirmation of termination.

We reserve the right to immediately terminate your membership and your access to the Website and its Service at any time if you have breached any part of this Agreement and we will send you a notice of termination at the e-mail address you provide in your application for membership or such other e-mail address as you may later provide to us. Please note that LoveStory.sg is not obliged to provide any reasons for such termination. Should we terminate your membership to the Website and its Service because you have breached any part of this Agreement, we will refund any pre-payments, excluding subscription fees, made by you less reasonable costs and losses we have incurred.

We can terminate this Agreement at any time by giving you reasonable advanced written notice.

If you have terminated your subscription, your subscription will remain active until the end of the period through which you had paid prior to your termination. In the case of violation of one or more of the Terms and Conditions of this Agreement by you, we reserve the right to block your account(s), delete prohibited content, and prevent publication of all or part of your profile. We may also block your access to all or part of the Website and its Service, either permanently or temporarily.

LoveStory.sg may deactivate the accounts of members who have not used the Website and its Service for a period of six months or more (as calculated by the date of last connection to the Website and its Service), unless you are a Premium Member.

2. SCOPE OF LOVESTORY.SG'S SERVICES

2.1 ONLINE SERVICES

LoveStory.sg is an internet information service that facilitates contact between members who may or may not be seeking friendship or a relationship. This Website and its Service enables you to contact other members through our internal e-mail system. LoveStory.sg is not a marriage brokering or mail order bride service and is not obligated to successfully broker any other members for you.

2.2 OFFLINE SERVICES

PerfectMatch will organise offline services like dating events, courses and personalised matchmaking. Please read the Terms and Conditions for such offline services in Clause 2.3.

2.3 GENERAL TERMS AND CONDITIONS FOR OFFLINE SERVICES

This Clause contains the general Terms and Conditions to PerfectMatch's offline services such as, but not limited to, dating events and courses.

Every care will be taken both by PerfectMatch and its business partners, hereinafter known as "Organisers", to ensure the safety of its participants during any offline dating event and course. However, PerfectMatch and its Organisers will not be responsible and disclaims all liability for any loss, liability, damage (whether direct, indirect or consequential), personal injury or expense of any nature whatsoever which may be suffered by you, as a result of or which may be attributable, directly or indirectly, to the participation in any of such sessions.

Should you wish to cancel your booking to any dating event or course, please note the following Cancellation Policy:

- i) More than 7 days – 90% refund
- ii) More than 3 days – 50% refund
- iii) Less than 3 days – Non-refundable

The above Cancellation Policy is subject to each Organiser's Cancellation Policy, if any, whichever more stringent.

It is also important that for every event and course which you intend to attend, you should read and accept each event or course Organiser's Terms and conditions which can be usually found on their websites, as part of LoveStory.sg's Linked Websites.

2.4 CUSTOMER SERVICE

LoveStory.sg provides assistance and guidance through its customer care representatives. When communicating with our customer care representatives, you may not display unacceptable behaviour such as being abusive, obscene, profane, offensive, sexist, threatening, harassing or racially offensive. If we feel that your behaviour towards any of our customer care representatives or other employees is at any time threatening or offensive, we reserve the right to immediately terminate your membership and you will not be entitled to any refund of unused subscription fees.

2.5 COMMUNICATION

LoveStory.sg reserves the right to send e-mails to you regarding changes or additions to the Website and its Service, or any products and services of LoveStory.sg and its affiliated businesses.

3. OBLIGATIONS OF MEMBER

3.1 OWN RISK

You acknowledge that your use of the Website and its Service is solely at your own risk.

3.2 ACCURATE INFORMATION

You represent, warrant and undertake that the information that you supply to the Service, the Website and the Company is accurate in all respects, not in breach of this Agreement and not harmful to any person in any way.

3.3 CONTENT POSTED ON THE WEBSITE

Other than personally identifiable information which relates to a living individual who can be identified from that information (e.g. full name, e-mail address, postal address, telephone number, etc), the use of which will be governed by our Privacy Policy, any material or information that you transmit or post to this Website will be considered non-confidential and non-proprietary, and we may use such material or information without restriction. We will have no obligations with respect to such material or information.

Specifically, you consent to us copying, disclosing, distributing, incorporating and otherwise use such material or information (including any data, images, sounds, text and other things) embodied therein for any and all commercial or non-commercial purposes.

LoveStory.sg may review and delete any content, messages, photos or profiles, known collectively as “Content”, that in the reasonable judgement of LoveStory.sg violate this Agreement or which might be offensive, illegal, or that might violate the rights, harm, or threaten the safety of members.

You are solely responsible for the Content that you publish, submit, post or display, hereinafter to be referred to as “post” on the Website, or transmit to other members via the Website. You represent and warrant that at any time of posting, the Content is accurate and current, not in breach of this Agreement, and not harmful to any person in any way.

3.4 PROHIBITED CONTENT

The following is a non-exhaustive list of the kind of Content that is illegal or prohibited on the Website. LoveStory.sg reserves the right to amend this list at any time and to investigate and take appropriate legal action in its sole discretion against anyone who violates this provision, including removing the offending communication from the Website and terminating the membership of such violators. The police will also be notified if the need arises.

- a) Content that promotes racism, bigotry, hatred or physical harm of any kind against any group or individual.
- b) Constitutes a profile or photographs of any third person used without their permission.
- c) Harasses or advocates harassment of another person, including the transmission of “junk mail”, “chain letters”, or unsolicited mass mailing or “spamming”.
- d) Promotes information that you know is false or misleading, promotes illegal activities or promotes conduct that is abusive, threatening, obscene, offensive defamatory or libellous, including but not limited to the distribution of any sexually and/or racially offensive, abusive, threatening, vulgar, obscene, harassing, libelous, slanderous, or objectionable material of any kind, nor any unlawful or illegal material, or any material that infringes or violates another party's rights (including, but not limited to, intellectual property rights and privacy rights).
- e) Promotes an illegal or unauthorised copy of another person's copyrighted work, such as providing pirated computer programs or links to them, providing information to circumvent manufacture-installed copy-protect devices, or providing pirated music or links to pirated music files.

- f) Contains restricted or password only access page, or hidden pages or images (those not linked to or from another accessible page).
- g) Post or transmit material which contains instructional information about illegal activities such as making or buying illegal weapons, violating someone else's privacy, or providing or creating computer viruses or other computer codes, files or programs which are designed to limit or destroy the functionality of computer software or hardware.
- h) Solicits passwords or personal identifying information for commercial or unlawful purposes from other members and engages in commercial activities and/or sales without our prior written consent such as contents, sweepstakes, barter, advertising, and pyramid schemes.

You must use the Website in a manner consistent with any and all applicable laws, regulations and codes of conduct. You shall not include in your member profile any telephone numbers, postal addresses, full names, URLs or e-mail addresses. You shall not engage in advertising to or solicitation of, other members to buy or sell any products or services through the Website or to attend parties or other social functions or networking for commercial purposes. You may not transmit any chain letters or junk e-mails to other members.

Although LoveStory.sg cannot monitor the conduct of its members of the Website, it is also a violation of this Agreement to use any information obtained from this Website in order to harass, abuse, or harm another person, or in order to contact, advertise to, solicit, or sell to any member without their prior explicit consent. In order to protect our members from such advertising or solicitation, LoveStory.sg reserves the right to restrict the number of e-mails which a member may send to other members in any 24-hour period to a number which LoveStory.sg deems appropriate in its reasonable discretion.

3.5 PROHIBITED ACTIVITIES

LoveStory.sg reserves the right to investigate and terminate your membership if you have misused the Website and its Service, or behaved in a way which could be regarded as inappropriate or whose conduct is unlawful or illegal. The following is a non-exhaustive list of the type of activities that you may not engage in with respect to LoveStory.sg.

- i) You will not impersonate any person or entity.
- ii) You will "stalk" or otherwise harass any person.
- iii) You will not express or imply that any statements you make are endorsed by LoveStory.sg without our specific prior written consent.

- iv) You will not use any robot, spider, site search/retrieval application, or other manual or automatic device or process to retrieve, index, “data mine”, or in any way reproduce or circumvent the navigational structure or presentation of the Website and its Service or its contents.
- v) You will not post, distribute or reproduce in any way any copyrighted material, trademarks or other intellectual property or proprietary information without obtaining the prior consent of the owner of such proprietary rights.
- vi) You will not remove any copyright, trademark or other proprietary rights notices contained in the Website and its Service.

If you reside in the Philippines, Belarus or any such jurisdiction that prohibits marriage-matching services to its residents, you hereby warrant, represent and covenant that you will not use Website or its Service for any purpose in breach of any legislation prohibiting marriage-matching.

You hereby acknowledge and agree that it is your sole responsibility to ensure that you do not breach any prohibition on marriage-matching, and further hereby acknowledge and agree that

the indemnity contained in Clause 9.1 will apply to your breach of any legislation prohibiting marriage-matching.

3.6 INFORMATION AVAILABLE OVERSEAS

You consent to the transfer of information provided by you (including Personal Information other than your full name, email address, residential address or phone numbers) to members residing in countries other than your country of residence.

3.7 LEGAL ACCESS

You must ensure that your access to the Website and its Service is not illegal or prohibited by laws which apply to you. You are solely responsible for the legality of your actions under all applicable laws.

3.8 EXPOSURE TO VIRUSES

You must take your own precautions to ensure that the process which you employ for accessing the Website does not expose you to the risk of viruses, malicious computer code or other forms of interference which may damage your own computer system.
